

Terms and Conditions Governing the “Pump S\$60 nett and stand a chance to win \$50 worth of SPC voucher” Promotion

1 Definitions

- 1.1 **“Bank”** or **“UOB”** means United Overseas Bank Limited.
- 1.2 **“Promotion”** refers to the “Pump S\$60 nett and stand a chance to win \$50 worth of SPC voucher” Promotion.
- 1.3 **“Eligible Cardmembers”** means all Principal and Supplementary Cardmembers of UOB whose UOB Card and whose UOB Card accounts are valid, subsisting, in good standing and satisfactorily conducted, as determined by UOB at its discretion.

Without limiting the generality of the above, the following persons shall not be eligible for the Promotion:

- (a) Persons who during the Qualifying Period are or have become mentally incapacitated, deceased, insolvent or who face legal incapacity;
 - (b) Persons who during the Qualifying Period face legal proceedings of any nature or have any legal proceedings of any nature threatened against them;
 - (c) Eligible Cardmembers whose accounts are terminated, closed or suspended at anytime during the Qualifying Period.
- 1.4 **“Qualifying Period”** is the period of time commencing at 0000hrs on 14 March 2016 to 2359hrs on 15 April 2016 (both dates inclusive).
- 1.5 **“SPC”** means Singapore Petroleum Company Limited Service Stations located in Singapore only.
- 1.6 **“Terms and Conditions”** means the terms and conditions of the Promotion, as may be amended from time to time.
- 1.7 **“UOB Card”** means any Credit or Debit Card issued by UOB in Singapore excluding:
- (i) any UOB JCB Card,
 - (ii) any UOB Travel Account, and
 - (iii) any Corporate Card on any corporate liability (including any Purchasing Card, Business Card, Multicurrency Corporate Card and Private Label Card).

2 Eligibility

- 2.1 The Promotion is open to Eligible Cardmembers subject to the following Terms and Conditions. Participation in the Promotion is deemed acceptance of these Terms and Conditions.
- 2.2 Notwithstanding anything herein to the contrary, UOB has the absolute discretion at any time and without having to give any reason, to determine the eligibility of the participants to participate in the Promotion.

3 Promotion – Entry

- 3.1 One (1) Tissue Box will be awarded to an Eligible Cardmember with minimum nett spend of S\$60 in a single receipt charged to the Eligible Cardmember's UOB Card at SPC ("**Qualifying Spend**") during the Qualifying Period.
- 3.2 A message will be printed on the underside of each Tissue Box's opening flap.
- 3.3 The aforementioned message will indicate if a Prize has been won by an Eligible Cardmember.
- 3.4 There is no limit to the number of Tissue Boxes available to each Eligible Cardmember (subject to availability, while stocks last), but each Eligible Cardmember will need to spend a minimum nett spend of S\$60 in a single receipt to receive a Tissue Box during the Qualifying Period.
- 3.5 An illustration on how an Eligible Cardmember achieves a minimum nett spend of S\$60 in petrol purchase in a single receipt is provided below (purely for illustrative purposes):

SPC&U Card discount	10% discount	S\$7.41
UOB Credit Card discount	5% discount	S\$3.70
S\$3 petrol discount for every S\$60 gross spend (S\$51 nett spend)	5% discount [†]	S\$3
Total savings		S\$14.11
Total nett charged amount		S\$74.11 – S\$14.11=\$60.00

[†]This 5% discount is derived as follows: S\$3/S\$60 X 100% = 5%.

- 3.6 Notwithstanding the foregoing, UOB has the absolute discretion to effect any adjustment, forfeiture or disqualification of the Promotion. UOB's determination shall be final and conclusive.

- 4.1 Each prize ("**Prize**") for the Promotion is S\$50 worth of SPC vouchers. SPC may impose terms and conditions on the use of the Prize.
- 4.2 There will be a total of 100 winners for the Qualifying Period.
- 4.3 UOB reserves the right to substitute any winner subsequently found to be ineligible or disqualified. UOB's determination of the winner(s) shall be final, conclusive and binding.

- 4.4 All prices and values of the Prize set out in any advertising, promotional, publicity and other materials are purely indicative and for information purposes only and such prices and values may vary in accordance with market fluctuations and other market conditions. UOB accepts no liability for any loss howsoever arising from the use of or reliance on such indicative prices and values.
- 4.5 The Prize is not exchangeable for cash or otherwise, in full or in part. Any unused portion of the Prize cannot be retained or refunded in cash, credit, other gifts or otherwise in full or in part.

5 Prize – Notification and Award of Prize

- 5.1 All winners are required to present the original Tissue Box flap indicating the eligible winning message together with (i) the original eligible UOB Card charged (ii) the eligible original Credit/Debit Card charge slip and (iii) original Cardmember's NRIC to claim the Prize.

- 6.2 By participating in the Promotion, the Participant is deemed to have consented to the collection, use and disclosure of his/her personal data by UOB, the organizers, sponsors, promoters and/or their respective contractors for verifying the eligibility of the Participant, conducting the Promotion, announcing/publicity of the winners of the Promotion (including having the Participant's photo and video taken/published), contacting the Participant regarding the foregoing, and all purposes and promotions incidental to the Promotion. A Participant who withholds his/her consent to collection, use and disclosure of his/her personal data under this paragraph 6 (Participation and Personal Data) shall be disqualified from the Promotion.
